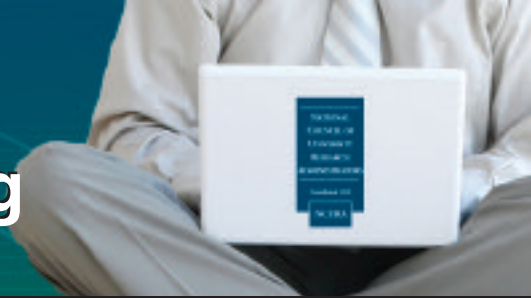

LEARN AT YOUR OWN PACE! Choose the start date that works best for you to begin your access to the online tutorial. You will have 8 weeks to complete the lessons and multiple choice final exam at your own pace - ALL lessons and the final are available from the start.

Federal Contracts are very different from federal grants. We have developed a thorough overview of this complex process to help you understand the unique characteristics of federal contracts, the process, the regulations and much more! The tutorial will offer interactive learning activities as well as knowledge reviews for each lesson. Students should expect to spend approximately 1 hour per lesson.

The course will end with a forty question multiple-choice final exam. Those who successfully pass the final exam (80% or higher) can download a certificate of completion.

Technical Requirements: Internet connection and a computer. For optimal performance please use Internet Explorer 5.0 or higher. Both Internet Explorer and Flash are strongly recommended and are available for download, free of charge, at the start of the tutorial.
