A Primer on Subawards Under Federal Assistance Awards

7 WEEK ONLINE TUTORIAL



LEARN AT YOUR OWN PACE! Choose the start date that works best for you to begin your access to the online tutorial. You will have 7 weeks to complete the lessons and the multiple choice final exam at your own pace – ALL lessons and the final are available from the start.

This online tutorial is focused on subcontracting programmatic effort under federal grants and other financial assistance awards. "Subcontracting" and "third party agreements" cover a wide variety of activities, too broad to be thoroughly addressed in an online tutorial. To alleviate this issue, the course has been divided into a series of lessons that deal with aspects of the subaward crucial to the Research Administrator.

It has been designed for Research Administrators who are relatively new to the field and, in particular, new to having responsibility for managing subawards. The course is a primer, meaning that it is intended to provide basic information on the topic for those who are just getting involved in it.

The tutorial will offer interactive learning activities as well as knowledge reviews. Students should expect to spend approximately 1 hour per lesson. The course will end with a multiple-choice final exam. Those who successfully pass the final exam (80% or higher) can download a certificate of completion.

Technical Requirements: Internet connection and a computer. For optimal performance please use Internet Explorer 5.0 or higher. Both Internet Explorer and Flash are strongly recommended and are available for download, free of charge, at the start of the tutorial.
